**PAYMENT AND CANCELLATIONS:** A deposit of 50% is required to confirm your hunt with the balance due 90 days prior to arrival. In the event of cancellation by the client more than 180 days prior to the start of your hunt, deposits shall be transferred to another hunt with us, or the deposit may be transferred to another mutually acceptable hunter secured by you. In the event of a cancellation is less than 180 days prior to the start of your hunt, deposits shall be forfeited unless transferred to a mutually acceptable hunter secured by you. In the event we must cancel a hunt, due to a failure on our part, the deposit shall be returned. All monies are U.S. funds. We recommend trip cancellation insurance, available at most travel agencies or check with your local insurance companies.

**GRATUITY:** Tips given to staff, guides, assistant guides, packers, pilots, and other camp personnel are considered as a standard practice by experienced hunters. If you consider your hunt a success and are satisfied with the personal services, tips are in order. Cash tips range from a \$500 for packers up to \$2,500 for your guide. Gifts of gear and equipment are standard, depending on your budget and level of satisfaction. They are very important to my staff.

**CONDITIONS:** All hunts are conducted on a fair chase basis in accordance with State of Alaska Hunting and guiding regulations. A State of Alaska Guide/Client hunt record will be signed prior to the start of each hunt. All hunters will need to sign a guide contract within 90 days after we receive your deposit, stating certain specifics of your hunt as required by Alaska state law. We accept a hunter on the following conditions: Mike Odin's Alaska Adventures, LLC and their guides are not responsible for accidents, equipment failure or loss, fire, theft, Acts of God or other vicissitudes of nature, or anything beyond our control. We request that you notify us in writing of any medical situations or special medications that you may be taking that could be helpful in case of an emergency, as well as a emergency contact name and phone number.

**Alaska Department of Fish and Game Hunting Regulations:**

"A big game tag may be used for another species of equal or lower value, but a tag may not be used more than once, nor can two or more tags be put onto one animal."

"State of Alaska license and tag fees, as well as hunting season dates are subject to change in July of each year by the Alaska Department of Fish and Game.
