

## **Guide – Client Agreement**

## for Brown Bear Hunting in Game Management Unit 8 (Kodiak Archipelago)

Pursuant to Alaska Administrative Code 5 AAC 92.061, all non-resident brown bear hunters in Game Management Unit 8 must provide the Alaska Department of Fish and Game with proof that they will be accompanied by a licensed, registered big game guide while they are in the field. This regulation does not pertain to non-resident hunters who are accompanied by a resident relative (second degree of kindred) and who obtained their permit in the resident drawing. To be considered for a permit, all other non-resident hunters must submit a completed copy of this form, by the application deadline noted in the current drawing hunt supplement, by mail, fax, e-mail scan, or in person to: Alaska Department of Fish and Game, Division of Wildlife Conservation, 211 Mission Road, Kodiak, AK 99615 (*fax* 907-486-1869) (*phone* 907-486-1880) (*e-mail* - carrie.butler@alaska.gov)
